In continuation to the intimation dated 12th August, 2023, Sula Vineyards Limited ("**Company**") has received an order dated 6th December, 2023 ("**Order**"), passed by the Assistant Commissioner CGST & Central Excise. The details of the Order are as follows:

Details of the violation(s) / contravention(s) committed or alleged to be committed	Pursuant to our GST Audit initiated in Aug-2022 and concluded in Oct-2022 for the Year 2017-18, 2018-19 & 2019-20, an Audit observation was raised by the Department for GST on various fees paid to the State Govt under Reverse Charge Mechanism. Response disagreeing with the audit observation was filed on 29th October, 2022 followed by detailed explanation. We have also received a Drop Proceeding Order received under Folio No.125/DC/NSK-I/ADJ/2022-23 dated 08/03/2023, on 12th April, 2023 where the department had accepted the similar contention on similar issue under Service tax regime. Subsequent to this, Show Cause notice dated 3rd August, 2023 was received on 11th August, 2023
3.	Nature and details of the action(s) taken, initiated or order(s) passed	The Assistant Commissioner CGST & Central Excise has passed order dated 06.12.2023 received by the Company on 08.12.2023 dropping the proceedings initiated vide Show Cause Notice
